Setup will be between 7:30 and 9:00 a.m. on the opening day of the event. Instructions for entering the area will be provided by GLCAC.
- 2. To be self-sustaining with my own power, if anything other than 110 voltage outlets are needed. There are no 220 voltage outlets available on site.
- 3. To provide all food, merchandise, and staff for my food truck during the event. (Alcoholic beverages are not to be sold at this event.)
- 4. To be responsible for all risk of loss or damage to merchandise or other property, regardless of cause. (Please obtain any insurance you want or feel the need for) for merchandise, and other property.
- 5. To provide GLCAC with a copy of my mobile food license within 2 business days from the date of our event., Vendors are expected to follow all rules and regulations as set forth by LivingstonCounty and comply with all City Health Inspectors and their agents.
- 6. To provide the \$100.00 fee to GLCAC when applying for a vendor space (i.e.: with the presentation of this signed contract). The fee is nonrefundable after April 20, 2026.
- 7. LIABILITY Food vendors are fully responsible for the care, safety and security of their work and property. Greater Livingston County Arts Council assumes no liability for loss or damage to art work or other property from any cause.
